

A the beginning of 2025, humanitarian needs remain significant, driven by a confluence of factors including ongoing conflicts particularly in Amhara and western Oromia regions, back-to-back climate shocks such as droughts, floods, and landslides, and recurrent health emergencies. Protection concerns persist in conflict-affected areas, compounding the vulnerabilities of those in need.

This includes gender based violence, violence against civilians, child separation, continuous forced eviction and destruction of properties, presence of mines and other unexploded ordnance. The La Niña-impacted October-December 2024 rains, which underperformed, in predominantly pastoralist areas in southern and southeastern parts of the country, are causing drought-like conditions, leading to water shortages, food insecurity and acute malnutrition in communities that are still recovering from the impact of the 2020-2023 drought¹.

CHILDREN IN ETHIOPIA



With about 126.5 million people (2023), Ethiopia is the second most populous nation in Africa after Nigeria, and one of the fastest-growing economies in the region, with an estimated 8.1% growth in FY2023/24. However, it also remains one of the poorest, with a per capita gross national income of \$1,020. Ethiopia aims to reach lower-middle-income status by 2025².

Ethiopia is home to approximately 13 million children under 5 years of age - approximately 16 percent of the total population of 126.5 million. By 2050, Ethiopia will have 58 million children under 18 years (6% of Africa)³.

Children remain at a high risk of living in poverty with limited access to essential services.



OUR WORK IN ETHIOPIA

- Our work in Ethiopia is focused on supporting children on the move and related, interlinked issues of child exploitation, mainly child trafficking, unsafe migration, child sexual exploitation, child labour, child marriage and female genital mutilation. Additionally, we provide vital humanitarian assistance.
- The current programmes in the country are centred around providing support to children who are suffering from man-made and natural crises, as well as empowering girls and young women by enhancing their decision-making power in all matters that affect their lives.
- Terre des Hommes Netherlands collaborates with local organisations and networks to implement both development and humanitarian projects. The projects aim to prevent child exploitation, provide assistance to exploited children and children experiencing conflict, and influence relevant policies and practices at the local and national levels.

OUR APPROACH

Children at the centre

Children are at the centre of everything we do. We support them to get access to education and other skills development so they can eventually find jobs to earn better incomes. We build their resilience and facilitate their empowerment. And we help them amplify their voice, opening opportunities to speak up to those with the power to realise systemic change.

Strengthening child protection

We educate parents and communities. We build the capacity of local structures to effectively prevent, detect, report and respond to child exploitation. We collaborate with other actors to influence the strengthening of the legal and policy environment for better promotion and protection of children's rights.



ACHIEVEMENTS

- 3 CSOs supported to undertake lobby and advocacy works on the rights and empowerment of girls and young women in Ethiopia.
- A panel discussion with 40 Women
 Parliamentarians (Cocus), government ministries
 and GYW was held to address barriers to
 leadership and call for increased support from
 ministries, parliament and policymakers and
 establish room for meaningful engagement and
 raise awareness in the community that young
 women take on leadership responsibilities.
- Seven Girls and Young Women representatives participated in the 40th GIMAC Network Pre-Summit CSOs Consultation which primarily focused on gender-responsive education, highlighting the importance of addressing gender disparities and promoting equality in educational systems
- One member of the Ethiopian Young Women Voice participated in the 68th Commissions on the Status Women (CSW68) in New York.
- A research to examine the ANRS family laws and its implementation with a view to identify



- gaps and challenges that impact the rights of vulnerable family members, primarily women and children has been conducted. Based on the research findings a total of 112 law re-enforcement bodies, community volunteers and other relevant stakeholders at regional level participated in the training to build their capacity on the implementation process of the Law.
- Girls' federation in Bahir Dar City took initiative to facilitate networking of Girls and Young Women champions, and protection of girls' rights with other stakeholders and CSOs as the project arranged an advocacy workshop on GBV/HTPs prevention with 35 decision makers, law enforcement organs, influential people and other stakeholders who have the capacity to influence the community.
- Girl's Advocacy campaign with 550 participants and a workshop with 44 participants organized on the 16 days of activism against GBV. These events enhanced the awareness of the community, strengthened partnership and collaboration among stakeholders and targeted communities for joint actions towards the prevention of GBV. The 16 days of activism consultation workshop served as a platform for girls and young women, especially survivors, to ask questions and express their concerns about prevalence and increment of gender-based violence in their community.
